BACKGROUND

Tsolo Agriculture and Rural Development Institute is an agricultural college that offers an academic programme to 200 learners. It also offers community training programmes to farmers and also on behalf of various partner organisations (departments, municipalities and private organisations).

Due to the ongoing load shedding, TARDI wishes to appoint a service provider to supply for own collection fuel (diesel and petrol) as well as related lubricants on as required basis for period of July 2022 to March 2023.

The Service Provider must provide the services of the item listed below.

PROJECT DESCRIPTION

TARDI will send a representative to collect the fuel weekly or as needed depending on load shedding stages.

SPECIAL CONDITIONS AND/OR REQUIREMENTS

- The Service Provider can be anywhere however the collection point (fuel station) must be within a 15-25km radius of TARDI.
- The fuel will be collected directly from a SABS approved fuel (garage station) and the Service Provider must be the Fuel (garage) station owner or have a contract with the fuel(garage station) where he/she will open an account for TARDI for the period advertised herein.
- TARDI must have **24hours** access to the services for the collection of fuel whenever needed.
- If not directly a fuel station, the TARDI account with the fuel station must be provided immediately after receiving the letter of appointment.
- Quantity of fuel will be will be adjusted as per fuel tariffs adjustments. And thus quote must bear this in mind as this will have a bearing on the final costs.
- A record book indicating collection date, amount and signed by both TARDI representative and service provider must be in place to keep track of fuel collected.

GENERAL CONDITIONS:


- No late or incomplete responses will be accepted for this RFQ
- Suppliers must ensure that no services are rendered or goods delivered without written confirmation from DRDAR
- **Only bidders who are registered on CSD as service providers, with Compliant Tax status or capable of being registered prior to the evaluation of submissions are eligible to submit bids. Bidders who are not registered on the CSD are not precluded from submitting bids, however bidders must compete the CSD application online, prior the closing date (www.csd.gov.za is the website). It is the responsibility of bidders to ensure that this requirement is complied with.**
