- In case of JV Agreement, a valid authentic JV agreement must be attached for the quotation to be considered further and must both submit the original and valid B-BBEE status level verification certificate or certified copies together with their quote.
- **Only bidders who are registered on CSD as service providers or capable of being registered prior to the evaluation of submissions are eligible to submit bids. Bidders who are not registered on the CSD are not precluded from submitting bids, however bidders must complete the CSD application online, prior the closing date (www.csd.gov.za is the website). It is the responsibility of bidders to ensure that this requirement is complied with.**
- Kindly note that you need to have a working email address, working cell phone, the company registration documents
- **Company Tax Matters must be Compliant and the Company must be in Business** -Tax compliance status and company directors of bidders will be verified on CSD for all price quotations and bids. Hard copies of Tax Clearance Certificate and CK documents are therefore no longer needed to be attached in the bid.
- **Valid BBEE Certificate/ Sworn Affidavit certified by SAPS must be attached to the Bid**
- **The department has the right to conduct a Security background check or Screening of the Service Provider and its Security personnel to ascertain the following requirements Registration with PSIRA, Criminal Record and Security Competency.**


